### **EXECUTIVE DIRECTOR & PRINCIPAL LETTER**

It is our pleasure to share with you highlights from the 2018-2019 school year. Every school year presents its own challenges and changes, and this last year was no exception. We were fortunate to be able to welcome new staff members to our team as we moved to fill a number of temporary and permanent vacancies. As always, our skilled and talented staff welcomed and provided support to each new member of the team.

We saw a record number of enrolments in our First Words Program last year. A change in BC Early Hearing Program protocols for intervention resulted in more babies being eligible for face to face intervention rather than being monitored through phone calls. We applaud this move as it ensures that all babies with hearing loss are receiving the necessary and appropriate intervention they require to reach their full potential.

In May, we came together as a community to celebrate the life of our colleague and friend, Patty Juno. Patty retired in June of 2018, and then in February 2019 she lost her battle with ALS. Her long career in this field touched many families, children and professionals. Her wit, creativity, and pragmatic approach to life continues to influence everyone who was fortunate enough to meet her.

In April it became apparent that we would have a record number of children attending our centre based programs in the fall—an increase of 25%. This increase included children 'graduating' from our First Words program as well as children transitioning from other programs.

We are thankful for our dedicated, multi-disciplinary team and proud of the work they do on a daily basis to ensure our students and families have the support they need to reach their full potential. As we look ahead we welcome input from all our families so that we are able to continue to meet the needs of our diverse community and ensure our children with hearing loss are able to fully participate in a hearing world. We also welcome your enthusiasm and your support. Together we are making a difference in the lives of our families and their children with hearing loss.






### **BREAKDOWN OF PROVIDED SERVICES**








#### **FUTURE PLANNED GIFTS**

Making a legacy gift is a thoughtful step today that leaves a footprint of caring for the future. Here are some options to consider:

#### **BEQUEST IN YOUR WILL**

A bequest is a direction in your Will that a certain sum of money, a particular financial asset, or a portion of the estate is to be given to Children's Hearing & Speech Centre of BC. A bequest made to the Centre generates a tax credit that offsets the tax otherwise payable on up to 100 per cent of your net income in the year of death. Unused credits can be carried back one year. These credits may result in a significant income tax savings and increase your net estate.

#### LIFE INSURANCE

You can make Children's Hearing & Speech Centre of BC the beneficiary of an existing or new life insurance policy. Giving life insurance is a way of making a significant gift without depleting your estate. At the end of your lifetime the policy proceeds will be paid by the insurance company directly to the Centre. Depending on how the policy is structured, you may receive a tax benefit during your lifetime or your estate will receive the benefit.

#### **RRSP/RRIF/TFSA**

You can name Children's Hearing & Speech Centre of BC as the direct beneficiary of the proceeds of your RRSP, RRIF or TFSA, or you can make a gift of the proceeds from your RRSP, RRIF or TFSA to the Centre in your will. The resulting tax credit may be used to offset the tax payable on the redemption of the proceeds of the retirement plan.
