About the Organization:

Children's Hearing and Speech Centre of BC (CHSC) is a non-profit family focused clinical and educational centre that teaches children who are deaf and hard of hearing to listen and talk, giving them the skills and confidence they need to achieve their fullest potential. CHSC has been offering listening and spoken language services for the past 59 years. All our programs and services are delivered by highly trained Teachers of the Deaf and Hard of Hearing, certified Early Childhood Educators, Speech and Language Pathologists, and our onsite Audiologist. We are the only listening and spoken language centre for children with hearing loss in all of Western Canada.

Tasks & Responsibilities:

The ECE assistant will be responsible for providing childcare support to children between the ages of 3 and 5 who attend our summer childcare program. They will help with child supervision, organizing activities, helping the ECEs with various tasks, and other related activities associated with childcare.

Experience & Qualifications:

- Prospective candidates should be currently enrolled in a Canadian accredited Early Childhood
 Education program and have a minimum of one course completed in their program. Recent graduates
 of a Canadian accredited ECE program looking to gain valuable hands-on experience are welcome to
 apply.
- Successful applicant must submit to a working with vulnerable criminal record check prior to the start of your employment. Standard First Aid is desirable, but not required.

Additional Eligibility Requirements (per Canada Summer Jobs program):

- Be between 15 and 30 years of age at the start of the employment*; be a Canadian citizen, permanent resident, or person to whom refugee protection has been conferred under the Immigration and Refugee Protection Act for the duration of the employment**; and, have a valid Social Insurance Number at the start of employment and be legally entitled to work in Canada in accordance with relevant provincial or territorial legislation and regulations
- *The youth must be 15 years of age at the beginning of the employment period. The youth may be more than 30 years of age at the end of the employment period as long as the youth was 30 at the beginning of the employment period.
- **International students are not eligible participants. International students include anyone who is temporarily in Canada for studies and who is not a Canadian citizen, permanent resident, or person who has been granted refugee status in Canada. Youth awaiting a refugee status ruling, as well as those who hold a temporary visitor visa, youth visa or work visa are ineligible. As the objective of the Canada Summer Jobs program is to support youth entering the Canadian labour market, the temporary nature of an international student's time in Canada does not allow for a long-term connection to the labour market.
